Attached is an application form for corporate membership of the International Data Links Society. Membership is available for government, public sector and commercial organisations. Corporate membership affords an organisation and its staff certain benefits within the Society. These include:

Benefits

- High visibility within the International Data Link community.

- Preferred status at IDLSoc International events including the annual Symposium (IDLS).
- Discounts at the IDLSoc Symposium when exhibiting or hiring meeting rooms, etc.
- A number of individual Society memberships for staff or non-staff. Individual Memberships provide access to the online IDLSoc website and its resources (worldwide membership directory with contact details, discussion forums, etc).
- Portfolio pages on the IDLSoc website in addition to press releases, training providers and job advertisements

Together with our corporate members, the Society is building upon the existing high standards throughout the Data Links communities. Corporate members will have priority in sponsoring Society events and are instrumental in developing the Society's future.

Annual corporate membership fees are based upon the total number of staff within the organisation applying. Corporate Member organisations can be entire organisations, divisions or departments.

Calculating Size of your Organisation

Where a member organisation represents a sub-division of a larger corporation, only the activities, representatives and employees of that sub-division will benefit from corporate membership.

For example, if XYZ GmbH of Geneva (50 employees) joined the Society, XYZ Inc of Florida (500 employees) will have to take up a separate corporate membership to benefit. However, if XYZ International (All XYZ employees worldwide) joined the society, all XYZ companies and employees worldwide would benefit from this single corporate membership.

Each corporate member will be required to nominate a representative as a point of contact for Society matters. This representative will receive information from the Society on upcoming events and correspondence from other Society members. Your corporate representative will also be issued with the individual membership credit codes. Each credit code can be used in exchange for a one-year Individual subscription to the Society. Credit codes are valid throughout the corporate member's subscription year.

Individual membership provides access to the IDLSoc website including the international membership directory, forums and news. Your organisation may use these credit codes for its own staff or is free to issue them to other individuals.
